

### Speaker: Alex McEachern, Power Standards Laboratory - Alex McEachern

regularly speaks at national and international conferences on electric power quality. He is a director of WPT (the parent company of Dranetz-BMI, Electrotek, and Daytronic), the founder of BMI, the former president of both BMI and Electrotek, and the author of everything from the Electric Power Measurements chapter of the <u>Encyclopedia of Electrical and Electronics Engineering</u> to the industry-standard <u>Handbook of Power Signatures</u>. These days he is concentrating his efforts on the Power Standards Laboratory, which provides equipment and services to verify compliance with electric power standards.

Active in drafting and approving international power standards, Alex represents the United States on the International Electrotechnical Commission (IEC) TF77A Working Group 9, which is setting the standard for power quality instruments. He is a Senior Member of the IEEE, Chairman of IEEE 1159.1, and a voting member of the IEEE Standards Coordination Committee on Power Quality.

Among all his accomplishments, McEachern is proudest of the fact that companies that he has created have been responsible for over 2,000 man-years of employment.

He is a reasonably inventive fellow, with 27 U.S. patents awarded so far, and he is well known for his cheerful, thought-provoking speeches.

# **Program Summary:**

- I. A History of Power Quality Monitoring Instrumentation. This session includes hands-on exhibits and practical anecdotes from 25 years around the world.
- II. A Discussion of Lock Washers, Solid-state Relays, and Wire-striping: How a Senior Engineer Thinks. This session will deal with practical illustrations of real-world problems and the thought process needed to eliminate them. For example, using the wrong type of lock washer on a PC board can result in circuit failure.
