Microturbine Cogeneration Plant Tour

Masonic Homes has a new Central Heating Plant (CHP) incorporating five (5) 60 KW natural gas fired microturbine generators. The microturbines generate electricity and hot water for the campus of buildings. Masonic Homes is a retirement community located on 1,400 acres of picturesque Lancaster County farmland. Masonic Homes is home to 1,400 residents and over 1,200 staff housed in 267 buildings.

PPL Energy Service Holdings, McClure Company, and Innovative Engineering Testing Construction (IETC) teamed up to perform engineering, procurement and construction of the new facility. The facility replaced an old coal fired boiler plant. The turbines satisfy a small percentage of the hot water continuously required by the residents. Dual fuel boilers provide supplemental hot water capacity. The electricity generated is used on campus to reduce purchased electricity from the electric utility (PPL).

Mr. Bill Luddy, P.E., President of IETC and Mr. Dan Kerr, P. E., Director of Design Build Services for McClure Company, will be the main speakers. IETC and McClure have performed a number of design/build projects together. The design/build cogeneration project incorporates the latest control technology and redundant heating equipment for project reliability. IETC is an electrical engineering, testing and construction firm with power quality and new power technology expertise. McClure Company is a large, mechanical design/build contractor, a PPL Company, and is the leader in construction of mechanical systems for this area.

A Power Point presentation will be provided to give an overview of the project, followed by a plant tour of the facility. Part of the equipment is outside, and the walk to the plant is approximately 0.25 mile, so please dress appropriately according to the weather.
